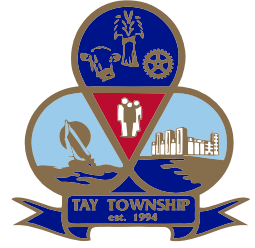

COMMITTEE OF ADJUSTMENT NOTICE OF MEETING FILE NO. 2024-B-16

This is a matter of an application made pursuant to Section 53 of the *Planning Act* to the Committee of Adjustment submitted by Lonnie Lewis, owner of **28** and **32 Industrial Road**, legally described as Plan 586, Part Lots 39 to 28 East, Doble Avenue, Part Doble Avenue, Register Plan 51R19048 Part 2, Township of Tay and Plan 586, Part Lots 24 to 28 and 39 to 43, Registered Plan 51R19048 Part 1, Township of Tay.

The application seeks a technical severance to re-establish the two (2) lots that were merged on title.

If you wish to be notified of the decision of the Committee of Adjustment in respect of the proposed consent application, you must make a written request to the Secretary-Treasurer.

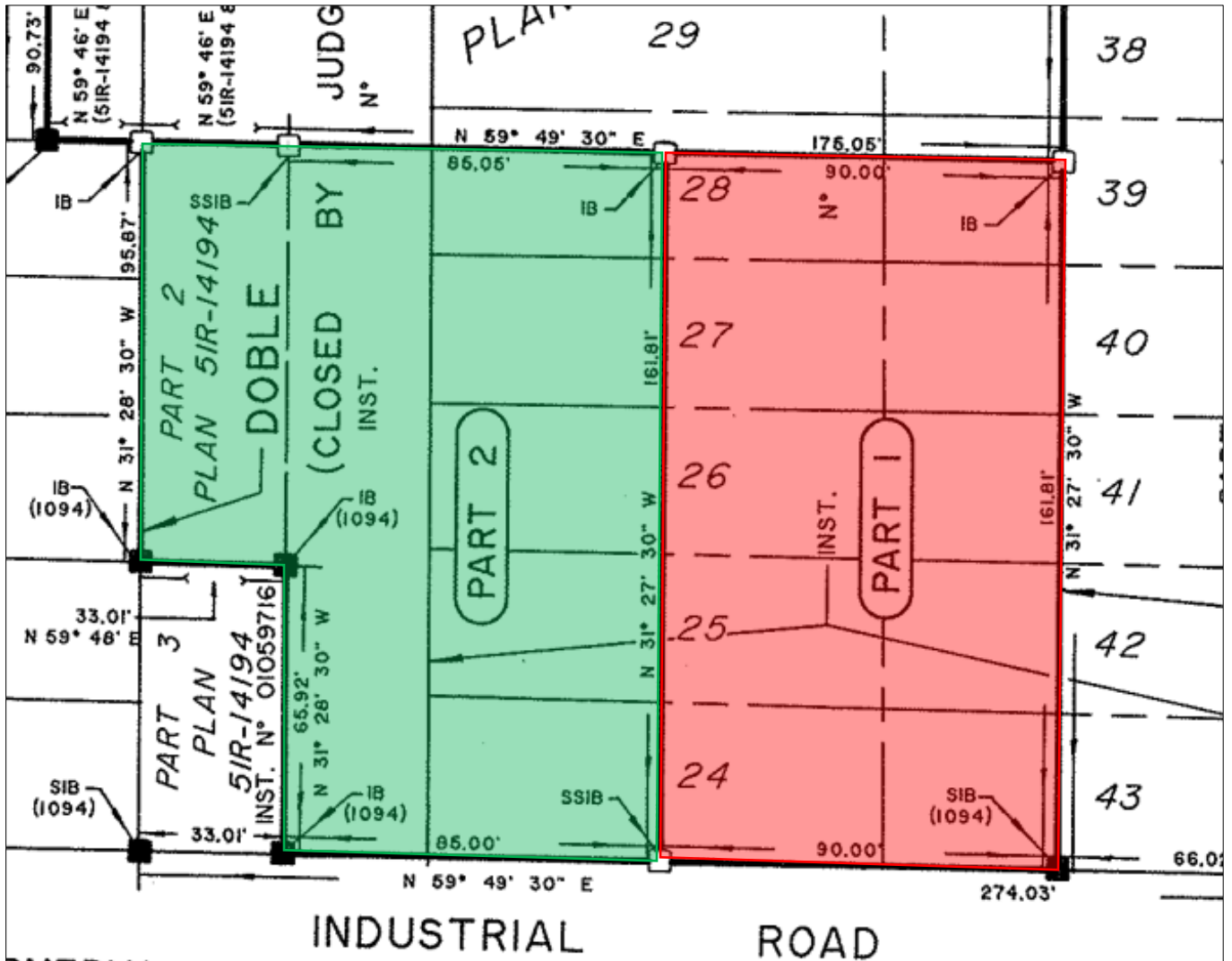
