This is a matter of an application made pursuant to Section 45 of the Planning Act to the Committee of Adjustment submitted by Dennis Bruner owner of **473 Arpin Street**, legally described as Plan 569, Lot 1406, Township of Tay.

The application as submitted seeks to fulfill a condition of consent application 2024-B-19. The applicant is requesting relief from two (2) provisions of the Township of Tay Zoning By-law 2000-57 as amended, to allow for a reduced lot area of 534.02 m2 (0.13 ac) and reduced lot frontage of 15.26 metres (50.06 feet), whereas a lot area of 557.0 m2 (0.14 ac) and a lot frontage 18.0 metres (59.05 feet) is required.


