### COMMITTEE OF ADJUSTMENT AMENDED NOTICE OF MEETING FILE NO. 2024-A-22

This is a matter of an application made pursuant to Section 45 of the Planning Act to the Committee of Adjustment submitted by Ouellet and Associates on behalf of Doug Seabrook, owner of **162 Robins Point Road**, legally described as Concession 8, Plan 809, Lot 34, Township of Tay.

The applicant is requesting relief from two (2) provisions of the Township of Tay Zoning By-law 2000-57 as amended, to permit the construction of a single detached dwelling with a setback from the 178.0 metres G.S.C. elevation of 10.92 m (35.82 ft) whereas a setback of 15.0 m (49.21 ft) is required, and a rear yard setback to the partially covered second storey deck of 6.52 m (21.39 ft) whereas 7.5 m (25.60 ft) is required.

The below chart summarizes the required and proposed reliefs:

Minimum Yards: Rear Yard	7.5 metres (25.60 feet)	6.52 metres (21.39 feet)




If you wish to be notified of the decision of the Committee of Adjustment in respect of the proposed minor variance, you must make a written request to the Secretary-Treasurer.




#### **ELEVATION DRAWING**
