COMMITTEE OF ADJUSTMENT NOTICE OF MEETING FILE NO. 2023-A-19

This is a matter of an application made pursuant to Section 45 of the Planning Act to the Committee of Adjustment submitted by Bernie Bianchi, owner of **140 Hoyt Avenue**, legally described as Concession 7, Part Lot 15, Township of Tay.

The applicant is requesting relief from one (1) provision of the Township of Tay Zoning By-law 2000-57 as amended, to permit the construction of a second-storey addition and covered deck on top of the existing rear open deck.

The below chart summarizes the required and proposed reliefs:

Section 4.31	Required	Proposed
No building or structure shall be located within 15.0 metres of the 178.0 metres G.S.C. elevation on a waterfront lot.	15.0 metres (49.2 feet)	7.0 metres (22.97 feet) from the 178.5 metre contour line to main wall of addition and covered deck.

A key map, site plan drawing, and elevation plan is included in this notice.

The Committee of Adjustment will consider this application on **Wednesday, November 15th, 2023, at 6:00 p.m.**

Take Notice that any person may make a submission in support of or in opposition to the proposed Minor Variance application. The Secretary-Treasurer will speak to the comments received as part of the presentation to Committee. **The Committee of Adjustment will be meeting remotely via Zoom video and telephone conference.**

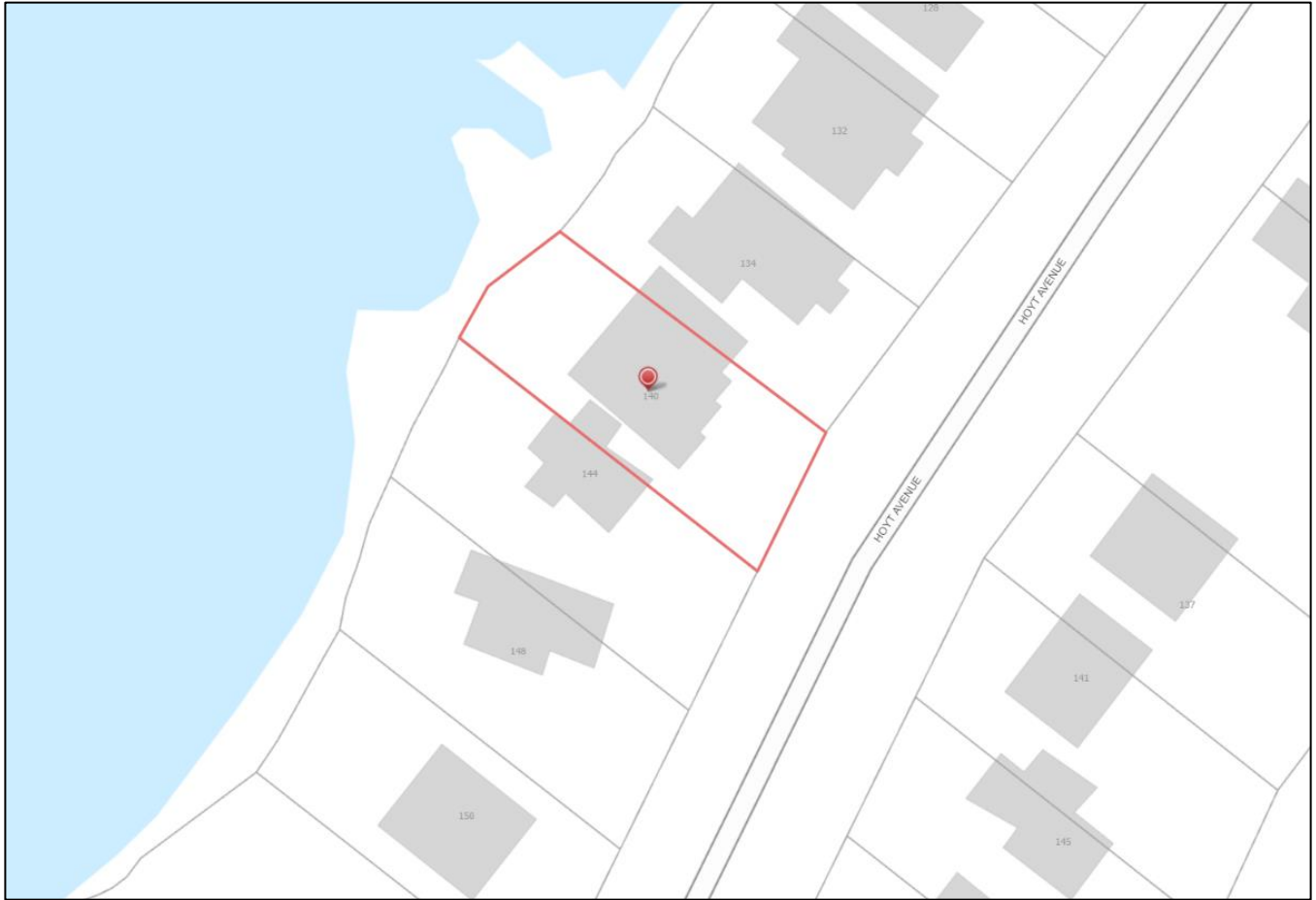

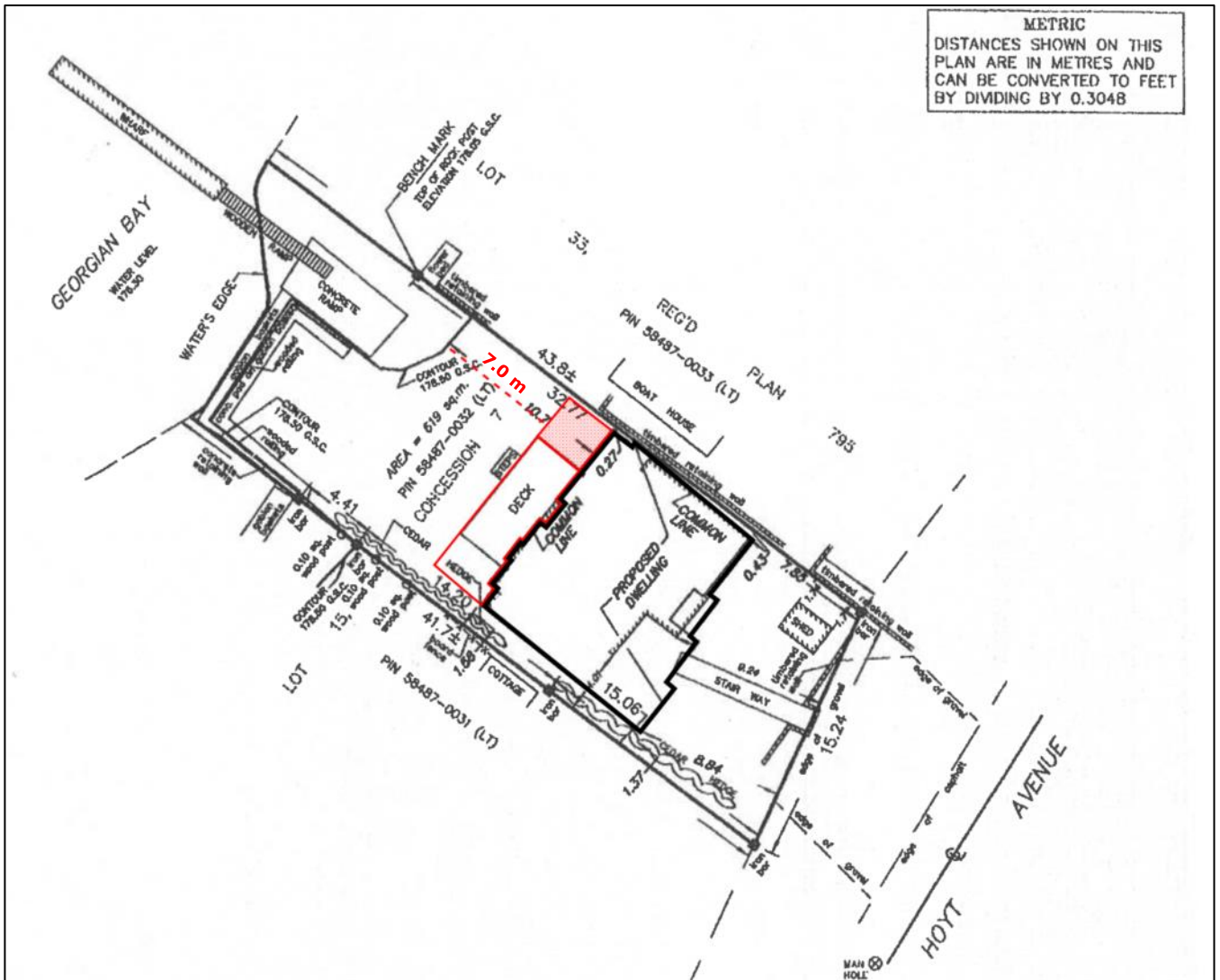
