COMMITTEE OF ADJUSTMENT NOTICE OF MEETING FILE NO. 2026-A-08

This is a matter of an application made pursuant to Section 45 of the Planning Act to the Committee of Adjustment submitted by Prycon Custom Building on behalf of Paul & Jane DeCola owners of **260 Waldie Avene**, legally described as Concession 7, Part Lot 14, Registered Plan 51R13262, Parts 1 and 2, Township of Tay.

The applicant is requesting relief from one (1) provision of the Township of Tay Zoning By-law 2000-57, as amended. The applicant is requesting permission to construct a second storey open deck with a rear yard setback of 7.43 m (24.37 ft) to the deck and 5.75 m (18.86 ft) to the edge of the stairs whereas, the minimum rear yard setback required is 15.0 m (49.21 ft).

The below chart summarizes the required and proposed reliefs:

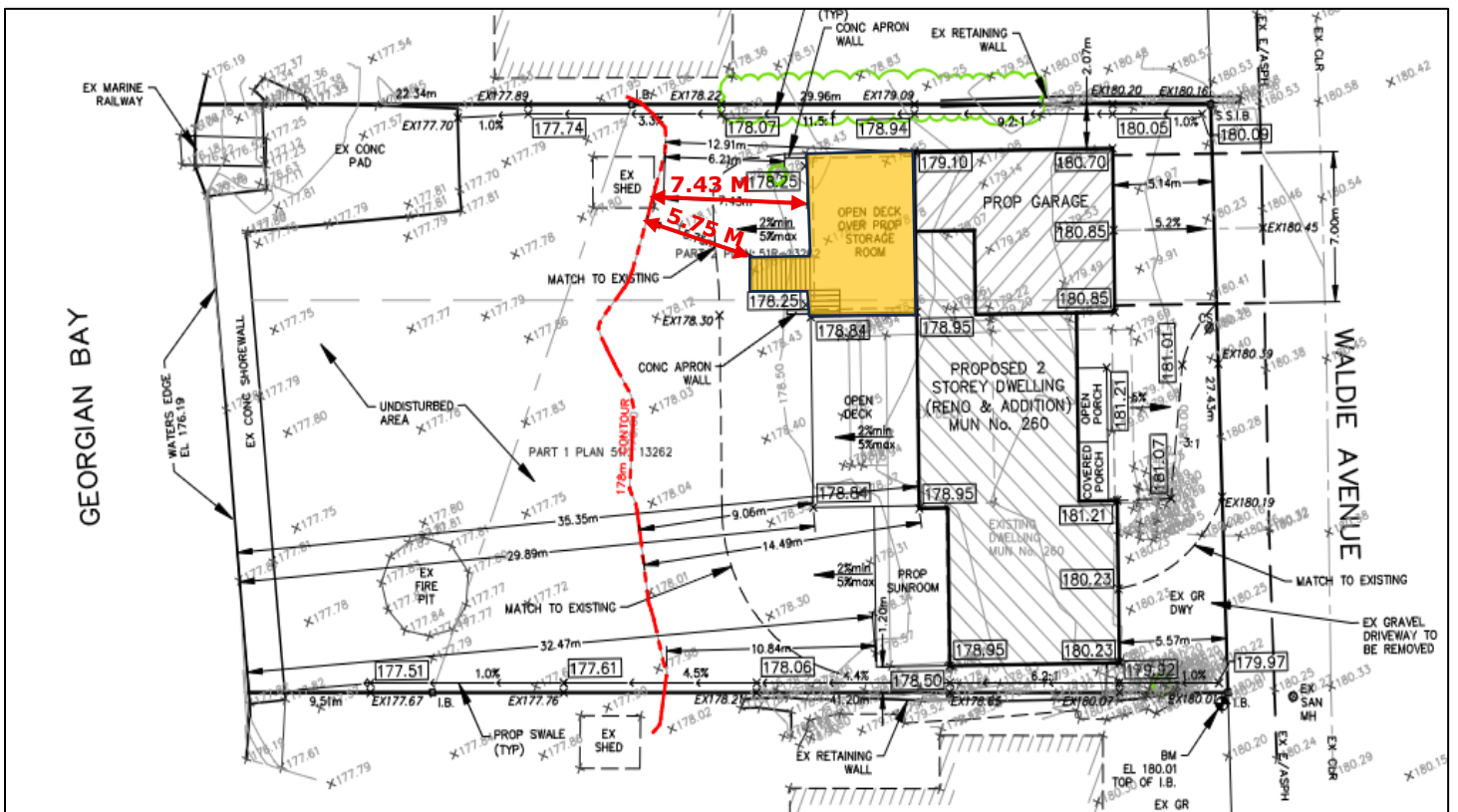
If you wish to be notified of the decision of the Committee of Adjustment in respect of the proposed minor variance, you must make a written request to the Secretary-Treasurer.
