COMMITTEE OF ADJUSTMENT NOTICE OF MEETING FILE NO. 2024-A-06

This is a matter of an application made pursuant to Section 45 of the Planning Act to the Committee of Adjustment submitted by Tim and Angela Grenier, owners of **520 Oleary Lane**, legally described as Plan 1340, Lot 11, Township of Tay.

The applicant is requesting permission for an enlargement to a non-complying structure. The applicant would like to construct an addition of 100.63 m² (1083.17 ft²) on to the existing dwelling. The existing dwelling is a non-complying use as the dwelling does not comply with the minimum setback requirement of 15.0 metres from the 178.0 metres G.S.C. elevation. The applicant is also requesting relief to permit the construction of a sunroom with an interior side yard setback of 0.36 metres, whereas 1.2 metres is required.

The below chart summarizes the required and proposed reliefs:

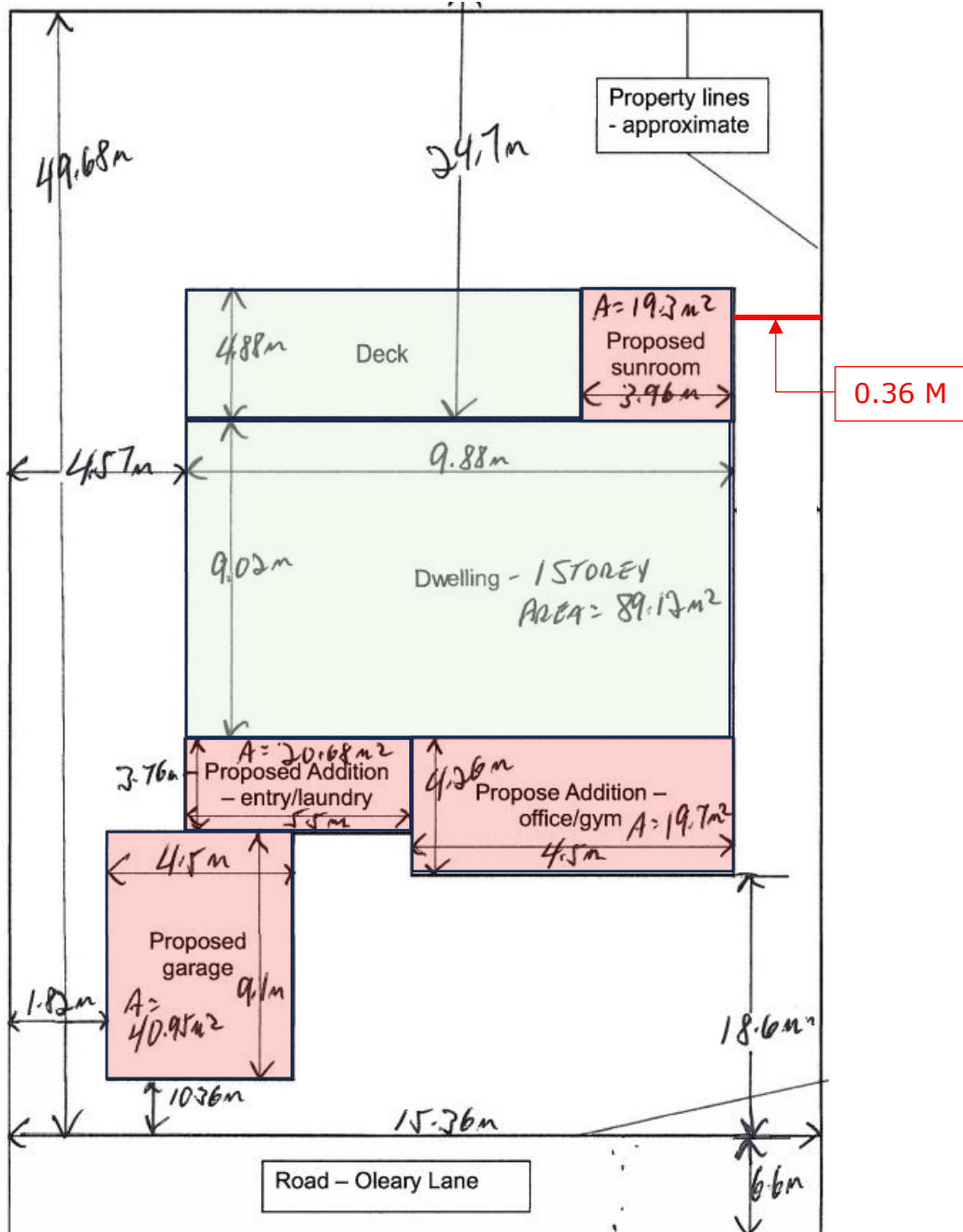
KEY MAP
