COMMITTEE OF ADJUSTMENT NOTICE OF MEETING FILE NO. 2026-B-08

This is a matter of an application made pursuant to Section 53 of the *Planning Act* to the Committee of Adjustment submitted by MeasEarth Inc. on behalf of the property owners of a **153 Veterans Lane**, legally described as Plan 201, Part Lot 5, Part Railways Lands, Registered Plan 51R28944, Parts 1 & 2, Township of Tay.

The purpose and effect of this application is a boundary adjustment for a portion of **153 Veterans Lane** which is to be consolidated with **149 Veterans Lane** to correct a paved portion of a driveway that encroaches on the subject lands. See below a chart and key map showing the proposal:

Benefiting Land (149 Veterans Lane)	Approx. 1830.0 m ² (19,697.96 ft ²)	Approx. 1832.99 m ² (19,730.14 ft ²)

If you wish to be notified of the decision of the Committee of Adjustment in respect of the proposed consent application, you must make a written request to the Secretary-Treasurer


