This is a matter of an application made pursuant to Section 53 of the *Planning Act* to the Committee of Adjustment submitted by Innovative Planning Solutions on behalf of Roger Bagnarol owner of **6790 Highway 93**, legally described as Tay Concession 1, West Part Lots 78 and 79, Registered Plan 51R42544, Part 1, Township of Tay.

The purpose and effect of this application is a request to sever the subject lands to create one (1) new lot, to be accessed by a mutual access easement between the proposed retain and severed lots with the following dimensions.
