**COMMITTEE OF ADJUSTMENT
NOTICE OF MEETING
FILE NO. 2025-A-24**

This is a matter of an application made pursuant to Section 45 of the Planning Act to the Committee of Adjustment submitted by Richard & Vicky Rumney, owners of **157 Mitchells Beach Road**, legally described as Concession 5, Plan 625, Lot 21, Township of Tay.

The applicant is requesting relief from two (2) provisions of the Township of Tay Zoning By-law 2000-57 as amended. The applicant is requesting permission to construct a detached garage with a front yard setback of 3.65 m. (11.98 ft.) and a total lot coverage of 18.64% (62.05 sq. m./667.92 sq. ft.), whereas, the minimum required front yard setback is 7.5 m. (24.6 ft.) and the maximum lot coverage permitted is 10% (33.29 sq. m./358.33 sq. ft.)

The below chart summarizes the required and proposed reliefs:

Section 8.3.1 (d)	Required	Proposed
(i) Minimum Required Yard: Front	7.5 metres (24.6 feet)	3.65 metres (11.98 feet)
Section 4.1.5	Permitted	Proposed
The maximum lot coverage for all detached accessory buildings and structures in the R1, R2, R3, SR, LSR, RMH, RE, RU and A Zones shall be 10%.	10% (33.29 sq. m./358.33 sq. ft.)	18.64% (62.05 sq. m./667.92 sq. ft.)

The Committee of Adjustment will consider this application on **Wednesday, November 19th, 2025, at 6:00 p.m.**

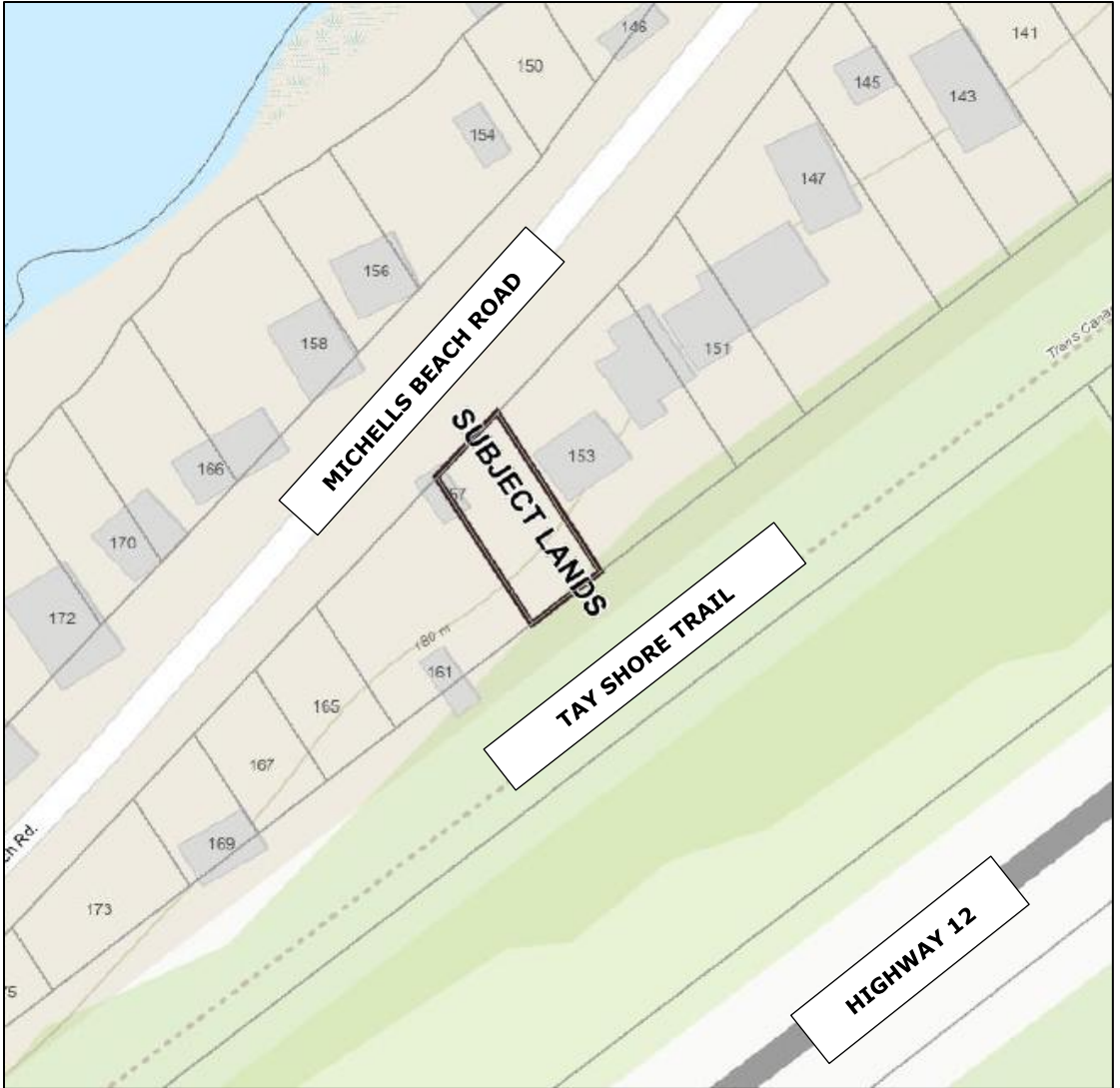

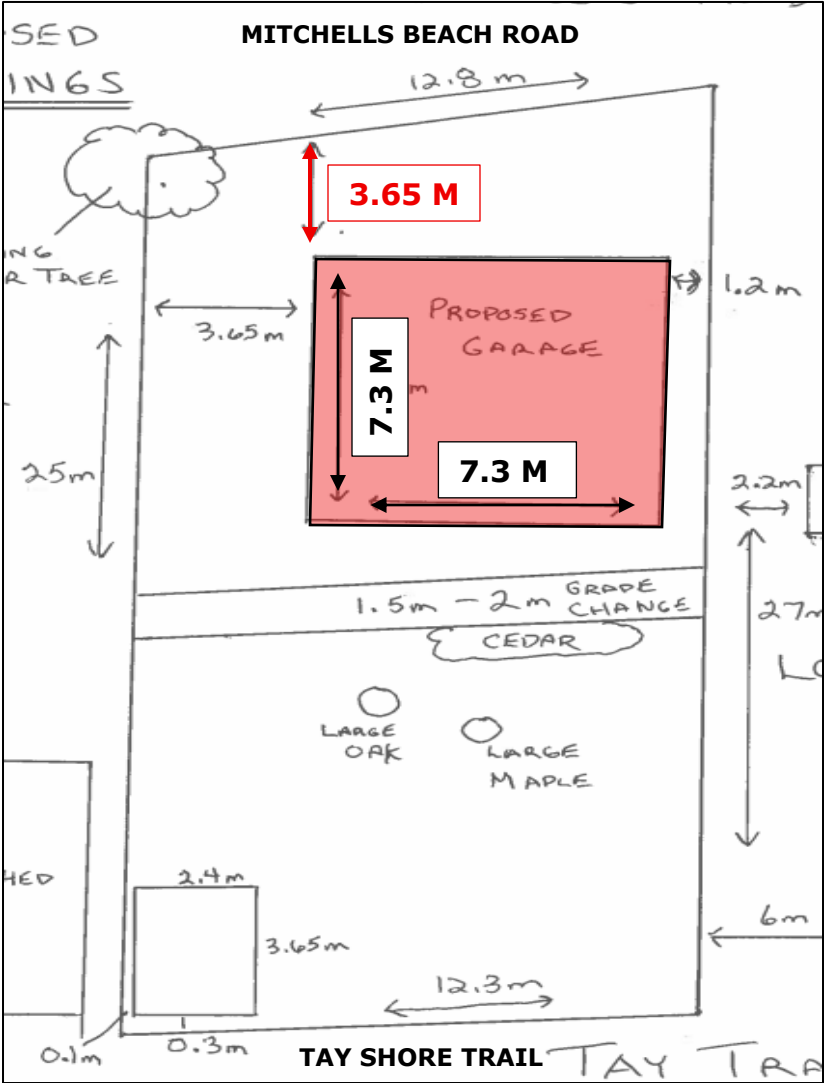
