This is a matter of an application made pursuant to Section 45 of the Planning Act to the Committee of Adjustment submitted by Paul DaCunha Architect on behalf of Maria & Michael Simas, owners of **105 Silver Birch Crescent**, legally described as Plan 922, Lot 122, Township of Tay.

The applicant is requesting relief from two (2) provisions of the Township of Tay Zoning By-law 2000-57 as amended. The applicant is requesting permission to construct a new single detached dwelling with a height of 7.82 m (25.66 ft), whereas the maximum permitted height is 7.0 m (22.97 ft) and a minimum setback of 15.0 m (49.21 ft) to the 177.0 metres G.S.C. elevation, whereas, a 15.0 m setback (49.21 ft) setback to the 178.0 metres G.S.C. elevation is required.

The below chart summarizes the required and proposed reliefs:




If you wish to be notified of the decision of the Committee of Adjustment in respect of the proposed minor variance, you must make a written request to the Secretary-Treasurer.
